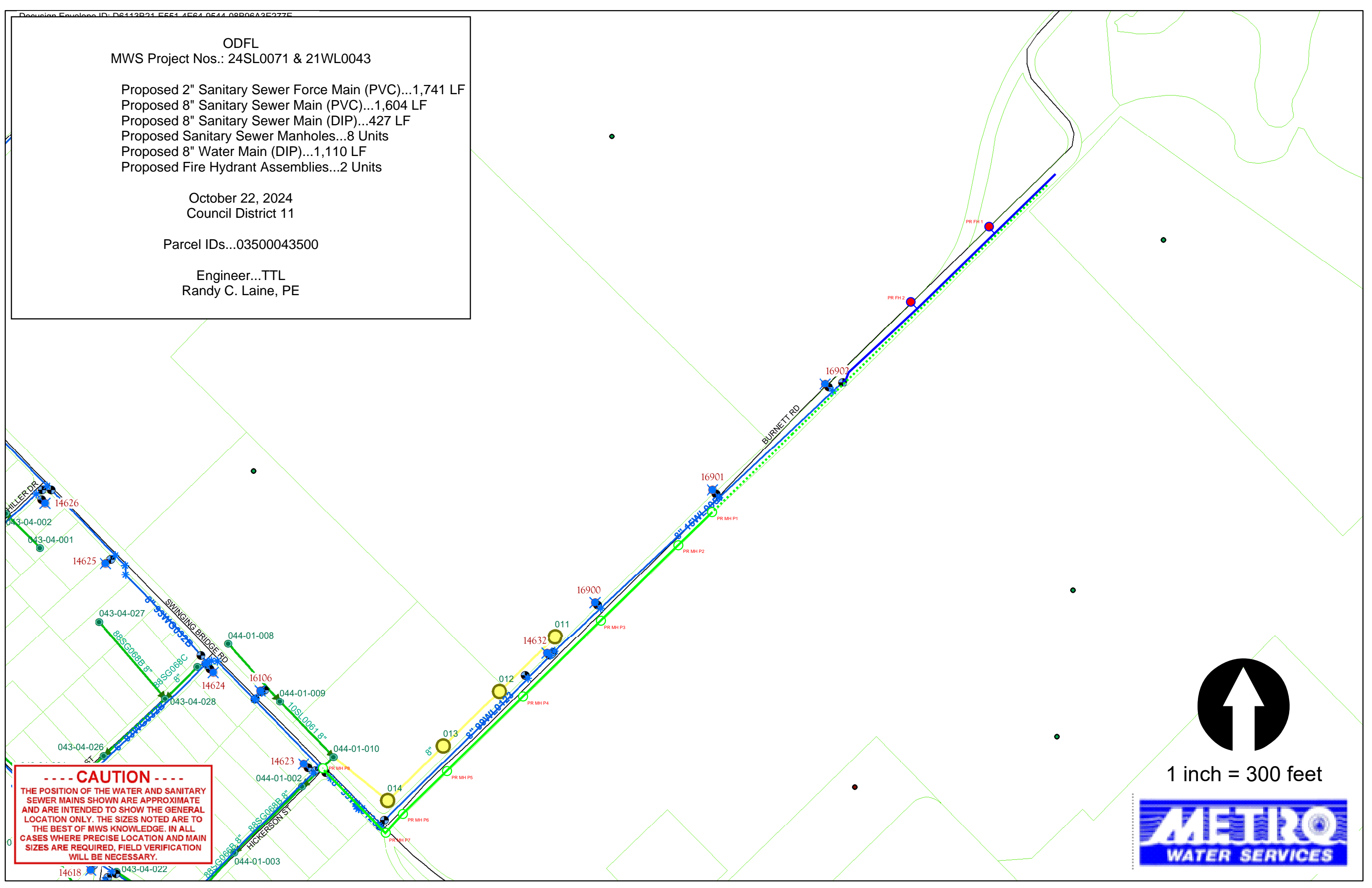

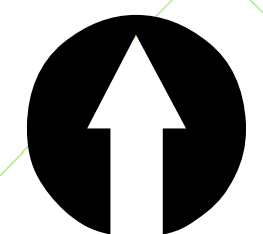

On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the acceptance of approximately 1,110 linear feet of eight-inch water main, two fire hydrant assemblies and approximately 1,741 linear feet of two-inch sanitary sewer force main (PVC), 1,604 linear feet of eight-inch sanitary sewer main (PVC), 427 linear feet of eight-inch sanitary sewer main (DIP), eight sanitary sewer manholes to serve the ODFL North Nashville development.
