A request to amend Council BL2020-357 and Proposal No. 2020M-050ES-001 by adding 47 linear feet of existing 6-inch water main to be relocated vertically (see sketch for details) to serve the One22One development (see associated MWS proj. nos. 19-WL-135 and 20-SL-19).

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. 






One 22 One - Revision 1
