Dear Members of the Metropolitan Board of Parks and Recreation:

Subject: Fisk Park Canopy Restoration Project

The tornado on March 3, 2020, was devastating for Nashville's tree canopy. Many of our city's parks sustained significant tree loss and damage, none more than Fisk Park in North Nashville, which lost approximately 90% of its trees (an estimated 120 of 130 total trees).

Eager to contribute to the tornado recovery efforts, the Garden Club of Nashville quickly identified Fisk Park for a possible tree planting project. As an affiliate of the Garden Club of America, the Garden Club of Nashville was eligible to apply for a Restoration Grant "to restore public landscapes or to conduct conservation projects in their communities that have been devastated by natural disasters."

The Garden Club of Nashville has secured two grants to execute this project:

- \$10,000.00 Restoration Grant from Garden Club of America
- \$9,654.50 Tennessee Agricultural Enhancement Program (TAEP) grant from TN Department of Agriculture, Division of Forestry

These funds will provide approximately 190 trees (combination of canopy and understory trees), mulch, tree tags, watering bags, and contract labor. Trees will be planted along the walking path, around the park's perimeter, and around the playground and picnic areas. Open areas will be preserved for recreation. The final planting plan, including species selection, will be coordinated with Mr. Lantz and Mr. Netsch.

The Garden Club of Nashville will partner with the Nashville Tree Foundation to execute the volunteer planting event, scheduled for Saturday, November 14, 2020. Additionally, the Nashville Tree Foundation will supplement Metro Parks' maintenance of the trees with watering, pruning and mulching during the first three years.

This is an in-kind gift, and no funds will be forwarded to Metro or Parks. Furthermore, the project does not require a match or other obligation from Metro or Parks. The Garden Club of Nashville respectfully requests approval from the Board of Parks and Recreation to move forward with the Fisk Park canopy restoration project.
