On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of approximately 517 linear feet of 8-inch sewer main (PVC), one sanitary sewer manhole and the acceptance of approximately 1,353 linear feet of 8-inch sanitary sewer main (PVC), 122 linear feet of 8-inch sanitary sewer main (DIP), 10 sanitary sewer manholes and approximately 950 linear feet of 8-inch water main (DIP), two fire hydrant assemblies and any associated easements (see sketch for details) to serve the Ridgeview Phase 2 development (MWS proj. nos. 18-SL-61 and 18-WL-61).

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.


