

Program Description:

Section 3201(a) of the American Rescue Plan Act of 2021, Pub. L. No. 117-2 (March 11, 2021), authorizes the Department of the Treasury ("Treasury") to make payments to certain eligible grantees to be used to provide emergency rental assistance. Established under the Consolidated Appropriations Act, 2021, this program allocates funding across the country to assist eligible households who are unable to pay rent and utilities due to the COVID-19 pandemic. Eligible renters are able to receive assistance with rent and utilities, unpaid rent and utilities, and other housing expenses that were incurred due to the COVID-19 pandemic. No matching requirement. The assistance listing number (CFDA number) for the ERA program is 21.023 and will be subject to Single Audit Requirements. Application date was signed by Mayor on 5/6/2021, Treasury Signed their side of the agreement on 5/26/2021 and initiated a 40% payment by ACH of the total award amount on the same day which was then deposited into Metro's Account the next day on 5/27/2021. The date both parties signed agreement of 5/26/2021 was listed as award date below. On 10/13/21 the Treasury department released the remaining 60% of our ERA2 Award in the amount of \$13,827,236.76 via ach in advance.

Plan for continuation of services upon grant expiration:

This grant is a one-time grant to aid people due to the COVID-19 Pandemic. Not knowing how many applications for assistance will be received each year, we allocated the current 40% amount of the total award as shown above that has been received so far by Metro Government to be budgeted with spending authority in current Metro FY.


