A resolution appropriating \$28,250 from a certain account of the Community Safety Fund for a grant to Rocketown of Middle Tennessee for Napier and Sudekum Community Safety programs.

WHEREAS, Section 7-3-314 of the Tennessee Code Annotated states that metropolitan forms of government may provide financial assistance to nonprofit organizations; and,

WHEREAS, Section 5.04.070 of the Metropolitan Code of Laws provides that the Council may, by Resolution, appropriate funds for the financial aid of nonprofit organizations; and,

WHEREAS, the Mayor's Office has recommended that \$28,250 of the funds appropriated for community safety grants in the Budget Ordinance (Substitute BL2023-1867), be distributed to Rocketown of Middle Tennessee; and,

WHEREAS, the grant will be utilized for services pertaining to Napier and Sudekum Community Safety programs; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that these funds be appropriated to Rocketown of Middle Tennessee.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. There is hereby appropriated \$28,250 from Fund No. 30164 to Rocketown of Middle Tennessee to provide services pertaining to Napier and Sudekum Community Safety programs.

Section 2. The grant contract between the Metropolitan Government of Nashville and Davidson County and Rocketown of Middle Tennessee for the amount provided herein and the purposes stated, a copy of which

is attached hereto and incorporated herein, is hereby approved.

Section 3. That this Resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This resolution appropriates \$28,250 from the Community Safety Fund for a grant to Rocketown of Middle Tennessee, Inc. for Napier and Sudekum Community Safety programs. The Mayor's Office recommended that \$28,250 of the funds appropriated for community safety programs in the Budget Ordinance (Substitute Ordinance BL2023-1867) be distributed to Rocketown. The funding would contribute to the compensation and benefits for a manager for the "Student Night Lights" program, which would include skating, e-sports and performing arts events and recording studio access. The grant would also provide for supplies and a portion of security costs for the program for five days a week between 3 p.m. and 6 p.m. Rocketown will also provide transportation for residents of Napier or Sudekum to and from the program services as part of the contract.

The grant term will begin on August 16, 2023 and end on December 31, 2023.
