An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to relocate a public fire hydrant assembly, for properties located at 750 and 754 Douglas Avenue (MWS Project Nos. 21-WL-47 and Proposal No. 2021M-051ES-001).

WHEREAS, the relocation of one public fire hydrant assembly, for properties located at 750 and 754 Douglas Avenue, is needed to construct project number 21-WL-47; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2021M-051ES-001 on June 10, 2021, for the relocation of said fire hydrant assembly.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to accept the relocation of one public fire hydrant assembly, for properties located at 750 and 754 Douglas Avenue, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are

authorized to execute such documents as may be necessary and appropriate to carry out the relocation authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This ordinance authorizes the relocation of one public fire hydrant assembly, for properties located at 750 and 754 Douglas Avenue. Future amendments to this ordinance may be approved by resolution.
