A resolution accepting a grant from David P. Crabtree to the Metropolitan Government, acting by and through the Metropolitan Nashville Parks and Recreation Department, to provide funding for improvements to Elizabeth Park and the surrounding area.

WHEREAS, David P. Crabtree has awarded a grant in an amount not to exceed \$10,000.00 with no cash match required to the Metropolitan Government, acting by and through the Metropolitan Nashville Parks and Recreation Department, to provide funding for improvements to Elizabeth Park and the surrounding area, a copy of which grant is attached hereto; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this grant be accepted.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the grant, by and between David P. Crabtree, in an amount not to exceed \$10,000.00, to the Metropolitan Government, acting by and through the Metropolitan Nashville Parks and Recreation Department, to provide funding for improvements to Elizabeth Park and the surrounding area, a copy of which grant is attached hereto and incorporated herein, is hereby approved.

Section 2. That the amount of this grant be appropriated to the Parks and Recreation Department.

Section 3. That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This resolution accepts a grant from David P. Crabtree in an amount not to exceed \$10,000, with no local cash match required, to the Metropolitan Nashville Parks and Recreation Department. This grant will provide funding for improvements to Elizabeth Parks and the surrounding area. There is no term for this grant.
