An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing public water main and to accept new public water main, for property located at 1212 McGavock Street (MWS Project No. 23-WL-94 and Proposal No. 2024M-046ES-001).

WHEREAS, the abandonment of approximately 215 linear feet of existing six-inch water main, and the acceptance of approximately 131 linear feet of new eight-inch water main, for property located at 1212 McGavock Street, is needed to construct project number 23-WL-94; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2024M-046ES-001 on March 20, 2024, for the abandonment and acceptance of said water mains.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to abandon approximately 215 linear feet of existing six-inch water main, and to accept approximately 131 linear feet of new eight-inch water main, for property located at 1212 McGavock Street, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

## 1212 McGavock Street

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are authorized to execute such documents as may be necessary and appropriate to carry out the abandonment and acceptance authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

## <u>Analysis</u>

This ordinance abandons approximately 215 linear feet of existing six-inch water main and accepts approximately 131 linear feet of new eight-inch water main for property located at 1212 McGavock Street.

This ordinance has been approved by the Planning Commission. Future amendments to this ordinance may be approved by resolution.

Fiscal Note: This ordinance has no cost to Metro. Abandoned and donated easements have no market value according to the Department of Water Services.
