NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the following building material restrictions and requirements as a part of BL2021-1003, a proposed Specific Plan Zoning District located at 1300 Hunters Lane, approximately 600 feet north of Dalemere Drive, are hereby authorized:

Building facades shall be constructed of brick, brick veneer, stone, cast stone, cementitious siding, or a
material substantially similar in form and function, unless otherwise approved on detailed building
elevations included with the preliminary SP
