A resolution appropriating a total of \$20,840 from the Nashville Public Library to various non-profit organizations for the provision of free and high-quality enrichment activities and/or field trips for youth during summer programming through the Library's Nashville After Zone Alliance out-of-school time coordinating system.

WHEREAS, Section 7-3-314 of the Tennessee Code Annotated states that metropolitan forms of government may provide financial assistance to nonprofit organizations in accordance with the guidelines of the Metropolitan Government; and,

WHEREAS, Section 5.04.070 of the Metropolitan Code of Laws provides that the Council may, by Resolution, appropriate funds for the financial aid of nonprofit organizations; and,

WHEREAS, the Library has accepted applications from non-profit organizations to receive funding from the Nashville After Zone Alliance coordinating system for the provision of free and high-quality enrichment activity support for youth summer programming; and,

WHEREAS, pursuant to BL2023-1867, additional funds are available for the provision of high-quality enrichment activity support for youth summer programming through the Library's Nashville After Zone Alliance program; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that these funds be appropriated to these nonprofit organizations.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF

NASHVILLE AND DAVIDSON COUNTY:

Section 1. There is hereby appropriated Twenty Thousand Eight Hundred Forty Dollars (\$20,840) from the Public Library to nonprofit organizations as follows:

- \$2,400 to Nashville Zoo;
- \$4,490 to Pass the Beauty, Inc.;
- \$5,000 to Rocketown of Middle Tennessee;
- \$4,000 to Team CJ Colas Uterine Cancer Foundation;
- \$4,950 to Youth Empowerment through Arts and Humanities.

Section 2. The Metropolitan Government is hereby authorized to enter into grant contracts, attached hereto and incorporated herein, with the nonprofit organizations listed in Section 1 for the amounts provided herein and the purposes stated. Such contracts shall specify the terms and conditions under which the grant funds are to be spent.

Section 3 That this Resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

<u>Analysis</u>

This resolution appropriates \$20,840 from the Nashville Public Library to five nonprofit organizations for the provision of educational, career, and cultural field trips and enrichment opportunities during May and June 2024 through the Library's Nashville After Zone Alliance out-of-school time coordinating system. The nonprofits are as follows:

- \$2,400 to Nashville Zoo
- \$4,490 to Pass the Beauty, Inc.
- \$5,000 to Rocketown of Middle Tennessee
- \$4,000 to Team CJ Colas Uterine Cancer Foundation
- \$4,950 to Youth Empowerment through Arts and Humanities

The resolution also authorizes Metro to enter into grant agreements with each of these organizations detailing the terms and conditions under which the grant funds are to be spent.
