A resolution accepting an in-kind grant from Vanderbilt University Medical Center to the Metropolitan Government, acting by and through the Metropolitan Nashville Fire Department, to provide training materials for paramedics who participate in the Prehospital Airway Control Trial (PACT) trauma airway study.

WHEREAS, Vanderbilt University Medical Center has awarded an in-kind grant, with an estimated value of \$15,000 with no cash match required, to the Metropolitan Government, acting by and through the Metropolitan Nashville Fire Department, to provide training materials for paramedics who participate in the Prehospital Airway Control Trial (PACT) trauma airway study; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this in-kind grant be accepted.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the in-kind grant by and between Vanderbilt University Medical Center, with an estimated value of \$15,000, to the Metropolitan Government, acting by and through the Metropolitan Nashville Fire Department, to provide training materials for paramedics who participate in the Prehospital Airway Control Trial (PACT) trauma airway study, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 2. That this in-kind grant be appropriated to the Metropolitan Nashville Fire Department based on the revenues estimated to be received and any match to be applied.

Section 3. That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan

Government of Nashville and Davidson County requiring it.

Analysis

This resolution accepts an in-kind grant from Vanderbilt University Medical Center (“VUMC”) to the Nashville Fire Department (“NFD”). NFD Emergency Medical Services will be participating in a trauma airway study. VUMC is the local research site for this Prehospital Airway Control Trial. NFD personnel must participate in trauma airway training and learn the rules of the study and the strict criteria to determine which patients can be enrolled in the study. VUMC will be providing this training, along with a challenge coin, medical back packs, and refreshments. The estimated value of this in-kind grant is \$15,000.
