An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to accept public sanitary sewer main, a sanitary sewer manhole and easements, for property located at 5800 Centennial Boulevard (MWS Project No. 20-SL-123 and Proposal No. 2020M-065ES-001).

WHEREAS, the acceptance of approximately 107 linear feet of new eight inch sanitary sewer main (PVC), one sanitary sewer manhole and easements, for property located at 5800 Centennial Boulevard, is needed to construct project number 20-SL-123; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2020M 065ES-001 on August 3, 2020, for the acceptance of said sanitary sewer main, a sanitary sewer manhole and easements.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to accept approximately 107 linear feet of new eight inch sanitary sewer main (PVC), one sanitary sewer manhole and easements, for property located at 5800 Centennial Boulevard, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are authorized to execute such documents as may be necessary and appropriate to carry out the acceptance authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

This ordinance authorizes the acceptance of approximately 107 linear feet of new 8 inch sanitary sewer main, one sanitary sewer manhole, and associated easements for property located at 5800 Centennial Boulevard. Future amendments to this legislation may be approved by resolution.

This ordinance has been approved by the planning commission.

Fiscal Note: This ordinance has no cost to Metro. Donated easements have no market value according to the Department of Metro Water Services.
