An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to accept a fire hydrant assembly for a property located at 1700 Pearl Street (MWS Project No. 19-WL-118 and Proposal No. 2021M-080ES-001).

WHEREAS, the acceptance of one fire hydrant assembly, for property located at 1700 Pearl Street, is needed to construct project number 19-WL-118; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2021M-080ES-001 on October 8, 2021, for the acceptance of a fire hydrant assembly.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to accept one fire hydrant assembly, for property located at 1700 Pearl Street, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are authorized to execute such documents as may be necessary and appropriate to carry out the acceptance

authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

<u>Analysis</u>

This ordinance authorizes the Metropolitan Government to accept one fire hydrant assembly for property located at 1700 Pearl Street. Future amendments to this ordinance may be approved by resolution.

This ordinance has been approved by the Planning Commission.
