Whereas, Americans for the Arts has awarded an in-kind grant with an estimated value of \$12,000.00 with a required cash match of \$24,000.00 to the Metropolitan Government, acting by and through the Metropolitan Nashville Arts Commission, to provide in-kind technical assistance for the DIAL program, a copy of which in-kind grant is attached hereto; and,

Whereas, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this in-kind grant be accepted.

Now, therefore, be it resolved by the Council of The Metropolitan Government of Nashville and Davidson County:

Section 1. That the in-kind grant by and between Americans for the Arts, with an estimated value of \$12,000.00 and the Metropolitan Government, acting by and through the Metropolitan Nashville Arts Commission, to provide technical assistance to help establish a summer internship program, a copy of which is attached hereto and incorporated herein, is hereby approved.
