WHEREAS, the Tennessee State Library and Archives is accepting applications for a Training Opportunities for the Public (TOP) grant with an award of \$9,456.00 and a required cash match of \$1,851.20 to provide funds for free technology training and equipment for use by members of the community; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this grant application be approved and submitted.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1.
