An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing water main, and to accept new water main, for property located at 2100 Century Farms Parkway (MWS Project No. 22-WL-12 and Proposal No. 2022M-062ES-001).

WHEREAS, the abandonment of approximately 200 linear feet of existing 12 inch water main (DIP), and the acceptance of approximately 200 linear feet of new 12 inch water main (DIP), in order to lower the profile of the pipeline in the ground, for property located at 2100 Century Farms Parkway, is needed to construct project number 22-WL-12; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2022M-062ES-001 on April 11, 2022, for the abandonment and acceptance of said water mains.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to abandon approximately 200 linear feet of existing 12 inch water main (DIP), and to accept approximately 200 linear feet of new 12 inch water main (DIP), in order to lower the profile of the pipeline in the ground, for property located at 2100 Century Farms Parkway, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are authorized to execute such documents as may be necessary and appropriate to carry out the abandonment and acceptance authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This ordinance abandons approximately 200 linear feet of existing 12 inch water main (DIP), and accepts approximately 200 linear feet of new 12 inch water main (DIP) in order to lower the profile of the pipeline in the ground for property located at 2100 Century Farms Parkway. Future amendments to this ordinance may be approved by resolution.

This ordinance has been approved by the Planning Commission.

Fiscal Note: This ordinance has no cost to Metro. Abandoned and donated easements have no market value according to the Department of Water Services.
