A resolution approving an application for a Bridge Investment Program grant from the Tennessee Department of Transportation to the Metropolitan Government, acting by and through the Nashville Department of Transportation and Multimodal Infrastructure (NDOT), to replace two bridges over CSX active rail lines within their right-of-way in the Madison and East Nashville neighborhoods.

WHEREAS, the Tennessee Department of Transportation is accepting applications for a Bridge Investment Program grant with an award of \$14,773,620.00 with a required cash match of \$3,693,405.00; and,

WHEREAS, The Metropolitan Government of Nashville and Davidson County is eligible to participate in this grant program; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this grant application be approved and submitted.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the Metropolitan Government's application for a Bridge Investment Program grant with an award of \$14,773,620.00, a copy of which is attached hereto and incorporated herein, is hereby approved, and the Nashville Department of Transportation and Multimodal Infrastructure is authorized to submit said application to the Tennessee Department of Transportation.

Section 2. That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This resolution approves an application for a Bridge Investment Program grant from the Tennessee Department of Transportation ("TDOT") to the Nashville Department of Transportation and Multimodal Infrastructure to replace two bridges over CSX active rail lines within their right-of-way in the Madison and East Nashville neighborhoods. If the grant is awarded, the grant award would be an amount not to exceed \$14,773,620 with a required local cash match of \$3,693,405.

The bridge in Madison is located on Due West Avenue and was rated in poor and structurally deficient condition by TDOT in April 2021. The bridge in East Nashville is located on Eastland Avenue and was rated in fair condition in May 2021.
