An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to accept new water main, for property located at 101 Factory Street, (MWS Project No. 22-WL-74 and Proposal No. 2022M-158ES-001).

WHEREAS, the acceptance of approximately 26 linear feet of new eight inch water main (DIP), for property located at 101 Factory Street, is needed to construct project number 22-WL- 74; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2022M-158ES-001 on October 19, 2022, for the acceptance of said water main.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to accept approximately 26 linear feet of new eight inch water main (DIP), for property located at 101 Factory Street, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

authorized to execute such documents as may be necessary and appropriate to carry out the acceptance authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

<u>Analysis</u>

This ordinance accepts approximately 26 linear feet of new eight-inch water main (DIP) for property located at 101 Factory Street.

Future amendments to this legislation may be approved by resolution. This ordinance has been approved by the Planning Commission.

Fiscal Note: This ordinance has no cost to Metro. Donated easements have no market value according to the Department of Water Services.
