A resolution accepting an in-kind grant from Nashville Youth Hockey League, Inc. to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to fund the purchase and installation of two Electro-Mech scoreboards on Rink B of the Centennial Sportsplex.

WHEREAS, Nashville Youth Hockey League, Inc. has awarded an in-kind grant, in an amount not to exceed \$20,000.00 with no cash match required, to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to fund the purchase and installation of two Electro-Mech scoreboards on Rink B of the Centennial Sportsplex; and;

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this in-kind grant be accepted.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the in-kind grant by and between Nashville Youth Hockey League, Inc., in an amount not to exceed \$20,000.00, to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to fund the purchase and installation of two Electro-Mech scoreboards on Rink B of the Centennial Sportsplex, a copy of which in-kind grant is attached hereto and incorporated herein, is hereby approved.

Section 2. That this in-kind grant be appropriated to the Parks and Recreation Department based on the revenues estimated to be received and any match to be applied.

Section 3. That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan

Government of Nashville and Davidson County requiring it.

<u>Analysis</u>

This resolution accepts an in-kind grant from the Nashville Youth Hockey League, Inc. to the Metropolitan Board of Parks and Recreation with an estimated value of \$20,000 with no cash match required. Nashville Youth Hockey League, Inc. has agreed to purchase and install two Electro-Mech scoreboards in Rink B of the Centennial Sportsplex. This was approved by the Board of Parks and Recreation at its December 6, 2022, meeting.
