A resolution approving amendment one to a grant from the Tennessee Department of Mental Health and Substance Abuse Services to the Metropolitan Government, acting by and through the Davidson County General Sessions Court, for the provision of the Tennessee Certified Recovery Court Program.

WHEREAS, the Metropolitan Government, acting by and through the Davidson County General Sessions Court, previously entered into a grant agreement with the Tennessee Department of Mental Health and Substance Abuse Services for the provision of the Tennessee Certified Recovery Court Program approved by RS2022-1522; and,

WHEREAS, the parties wish to amend the grant agreement to increase the amount of the grant by \$6,000.00 from \$60,000.00 to \$66,000.00, a copy of which amendment one is attached hereto; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that amendment one be approved.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1: That amendment one to the grant by and between the Tennessee Department of Mental Health and Substance Abuse Services and the Metropolitan Government, acting by and through the Davidson County General Sessions Court, for the provision of the Tennessee Certified Recovery Court Program, a copy of which amendment one is attached hereto and incorporated herein, is hereby approved, and the Metropolitan Mayor is authorized to execute the same.

Section 2: That this resolution shall take effect from and after its adoption, the welfare of the Metropolitan Government of Nashville and Davidson County requiring it.

<u>Analysis</u>

This resolution approves the first amendment to a grant from the Tennessee Department of Mental Health and Substance Abuse Services to the Davidson County General Sessions Court, originally approved by Resolution No. RS2022-1522. This grant is used for the provision of the Tennessee Certified Recovery Court Program. The end date of this grant is June 30, 2023.

This amendment increases the total grant award by \$6,000, from \$60,000 to \$66,000. The grant budget attachment would be replaced to reflect this change. No other changes would be made to the agreement.
