An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to accept new public water and sanitary sewer mains, fire hydrant assemblies, sanitary sewer manholes and easements, for property located at 6018 Mount View Road, also known as Campbell Crossings Townhomes (MWS Project Nos. 20-WL-80 and 20-SL-154 and Proposal No. 2023M-018ES-001).

WHEREAS, the acceptance of approximately 645 linear feet of new eight-inch water main (DIP), approximately 899 linear feet of new eight-inch sanitary sewer main (PVC), approximately 782 linear feet of new eight-inch sanitary sewer main (DIP), three fire hydrant assemblies, 12 sanitary sewer manholes and easements, for property located at 6018 Mount View Road, also known as Campbell Crossings Townhomes, is needed to construct project numbers 20-WL-80 and 20-SL-154; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2023M-018ES-001 on February 3, 2023, for the acceptance of said water and sanitary sewer mains, fire hydrant assemblies, sanitary sewer manholes and easements.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to accept approximately 645 linear feet of new eight-inch water main (DIP), approximately 899 linear feet of new eight-

inch sanitary sewer main (PVC), approximately 782 linear feet of new eight-inch sanitary sewer main (DIP), three fire hydrant assemblies, 12 sanitary sewer manholes and easements, for property located at 6018 Mount View Road, also known as Campbell Crossings Townhomes, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are authorized to execute such documents as may be necessary and appropriate to carry out the acceptance authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

## **Analysis**

This ordinance accepts approximately 645 linear feet of new eight-inch water main (DIP), approximately 899 linear feet of new eight-inch sanitary sewer main (PVC), approximately 782 linear feet of new eight-inch sanitary sewer main (DIP), three fire hydrant assemblies, 12 sanitary sewer manholes and easements for property located at 6018 Mount View Road, also known as Campbell Crossings Townhomes.

Future amendments to this legislation may be approved by resolution. This ordinance has been approved by the Planning Commission.

Fiscal Note: This ordinance has no cost to Metro. Donated easements have no market value according to the Department of Water Services.
