An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to accept the relocation of an existing public fire hydrant assembly and a new public sanitary sewer manhole, for property located at 210 2nd Avenue North, also known as 2nd Avenue Streetscape Improvements - North Block (MWS Project Nos. 22-WL-142 and 22-SL-293 and Proposal No. 2023M-039ES-001).

WHEREAS, the acceptance of the relocation of one existing fire hydrant assembly and one new sanitary sewer manhole, for property located at 210 2<sup>nd</sup> Avenue North, also known as 2nd Avenue Streetscape Improvements - North Block, is needed to construct project numbers 22-WL-142 and 22-SL-293; and,

WHEREAS, the Metropolitan Planning Commission approved mandatory referral No. 2023M-039ES-001 on March 20, 2023, for the acceptance of the relocation of said fire hydrant assembly and said sanitary sewer manhole.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan Government of Nashville and Davidson County is authorized to accept the relocation of one existing fire hydrant assembly and one new sanitary sewer manhole, for property located at 210 2nd Avenue North, also known as 2nd Avenue Streetscape Improvements - North Block, as shown on Exhibit 1, which is attached hereto and incorporated by reference.

Section 2. The Directors of Water and Sewerage Services and Public Property Administration are authorized to execute such documents as may be necessary and appropriate to carry out the acceptance authorized by this ordinance.

Section 3. Amendments to this legislation shall be approved by resolution.

Section 4. This ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

#### Analysis

This ordinance accepts the relocation of one existing fire hydrant assembly and one new sanitary sewer manhole, for property located at 210 2<sup>nd</sup> Avenue North, also known as 2nd Avenue Streetscape Improvements - North Block.

Future amendments to this legislation may be approved by resolution. This ordinance has been approved by the Planning Commission.

*Fiscal Note: This ordinance has no cost to Metro. Abandoned and donated easements have no market value according to the Department of Water Services.*
