A resolution accepting a grant from the State of Tennessee, Department of Environment and Conservation to the Metropolitan Government of Nashville and Davidson County, acting by and through the Metropolitan Department of Water and Sewerage Services Stormwater NPDES Office, to construct stormwater swales and stormwater detention basin features at the Metro Nashville Police Impound Lot.

WHEREAS, the State of Tennessee, Department of Environment and Conservation, has awarded a grant in an amount to not to exceed \$500,000.00 and a required match of \$150,000.00; and,

WHEREAS, it is to the benefit of the citizens of the Metropolitan Government of Nashville and Davidson County that this grant be accepted.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the grant by and between the State of Tennessee, Department of Environment and Conservation, in an amount not to exceed \$500,000.00, to the Metropolitan Department of Water and Sewerage Services Stormwater NPDES Office, to construct stormwater swales and stormwater detention basin features at the Metro Nashville Police Impound Lot, a copy of which is attached hereto and incorporated herein, in hereby approved and accepted.

Section 2. That the amount of this grant is to be appropriated to the Metropolitan Department of Water and Sewerage Services Stormwater NPDES Office based on the revenues estimated to be received and any match to be applied.

Section 3. That this resolution shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This resolution accepts a grant from the Tennessee Department of Environment and Conservation to the Metropolitan Department of Water and Sewerage Services Stormwater NPDES Office to construct stormwater swales and stormwater detention basin features at the Metro Nashville Police Impound Lot. The grant award is not to exceed \$500,000 with a required match of \$150,000. The term of this grant agreement begins March 1, 2023 and ends on September 30, 2025.
