Department of Justice is accepting applications for a Community Policing Development - Officer Recruitment grant with an award of \$175,000.00 with no cash match required to increase the number of qualified applicants and retain current officers by creating a positive work environment that supports diversity and inclusivity; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this grant application be approved and submitted.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1.
