NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

SECTION 27. That Section 17.36.220 of the Metropolitan Code of Laws is hereby amended by deleting Stormwater Management Committee and inserted in lieu thereof Stormwater Management Commission.

SECTION 28. Amendments to this ordinance may be approved by resolution of the Metropolitan Council.

SECTION 29. This ordinance shall take effect on July 1, 2023, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

### <u>Analysis</u>

This ordinance amends Chapters 15 and 17 the Metropolitan Code to rename the "Stormwater Management Committee" to the "Stormwater Management Commission". No changes are proposed to the Commission's authority.

The Planning Commission recommended approval of this ordinance at their June 22, 2023 meeting.
