WHEREAS, the Metropolitan Council desires to appropriate to certain accounts for the benefit of the Davidson County Sheriff's Office and Metropolitan Nashville Public Schools in the amount of <u>Ten</u> Four Million, <u>Eight</u> Three Hundred Thousand Dollars (\$10,800,0004,300,000) from revenues of the General Fund and <u>Metropolitan Nashville Public Schools General Purpose Fund, respectively</u>.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:
