A resolution approving an intergovernmental license agreement between The Metropolitan Government of Nashville and Davidson County and the United States of America, acting by and through the Department of Defense, to enter certain property located at 1414 County Hospital Road owned by The Metropolitan Government, for limited military training purposes. (Proposal No. 2023M-028AG-001)

WHEREAS, the Metropolitan Government of Nashville and Davidson County, desires to enter into a license agreement with the United States of America, acting by and through the Department of Defense, to enter property owned by the Metropolitan Government located at 1414 County Hospital Road; and,

WHEREAS, the license agreement is attached hereto and incorporated herein; and,

WHEREAS, the license agreement provides a revocable license to the United States, acting by and through the Department of Defense, to enter the aforementioned property to conduct military training for Department of Defense personnel; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that the license agreement be approved.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1: The license agreement between The Metropolitan Government of Nashville and Davidson County

and the United States of America, acting by and through the Department of Defense, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 2: That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This resolution approves an intergovernmental license agreement between the Metropolitan Government and the United States Department of Defense. Pursuant to this license agreement, the Department of Defense would be able to enter property owned by the Metropolitan Government located at 1414 County Hospital Road for the purpose of conducting military training for Department of Defense personnel.

The license is to remain in effect from September 11 to 12, 2023. The Council Office has been advised that this training will consist of individuals working to locate and disarm inert explosive devices, including their ability to reach target packages, perform hand entry techniques, and "disarm" the fake devises. No guns or live explosives will be used during this training.

Fiscal Note: The Department of Defense will use the Metro owned property at 1414 County Hospital Road to conduct military training for personnel at no cost under this agreement.
