A resolution accepting an in-kind grant from the Centennial Park Conservancy to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to fund the purchase and installation of an Art Sentry Security System at the Parthenon.

WHEREAS, the Centennial Park Conservancy has awarded an in-kind grant in an amount not to exceed \$182,125 with no cash match required to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to fund the purchase and installation of an Art Sentry Security System at the Parthenon; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this in-kind grant be accepted.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the in-kind grant by and between the Centennial Park Conservancy, in an amount not to exceed \$182,125, to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to fund the purchase and installation of an Art Sentry Security System at the Parthenon, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 2. That this in-kind grant be appropriated to the Metropolitan Nashville Parks and Recreation Department based on the revenues estimated to be received and any match to be applied.

Section 3. That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

## **Analysis**

This resolution accepts an in-kind grant from the Centennial Park Conservancy to the Metropolitan Department of Parks and Recreation. The value of the in-kind grant is \$182,125 and requires no cash match. This in-kind grant would fund the purchase and installation of an Art Sentry Security System at the Parthenon.

This grant was approved by the Board of Parks and Recreation on February 6, 2024.
