A resolution accepting an in-kind grant from the Friends of Warner Parks to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to provide funding for the renovation and expansion of the Warner Park Headquarters.

WHEREAS, the Friends of Warner Parks have awarded an in-kind grant in an amount not to exceed \$3,000,000 with no cash match required to the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to provide funding for the renovation and expansion of the Warner Park Headquarters; and,

WHEREAS, it is to the benefit of the citizens of The Metropolitan Government of Nashville and Davidson County that this in-kind grant be accepted.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the in-kind grant by and between the Friends of Warner Parks, in an amount not to exceed \$3,000,000, and the Metropolitan Government, acting by and through the Metropolitan Board of Parks and Recreation, to provide funding for the renovation and expansion of the Warner Park Headquarters, a copy of which in-kind grant is attached hereto and incorporated herein, is hereby approved.

Section 2. That the amount of this in-kind grant be appropriated to the Metropolitan Nashville Parks Department based on the revenues estimated to be received and any match to be applied.

Section 3. That this resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Analysis

This resolution accepts an in-kind grant from Friends of Warner Parks to the Metropolitan Department of Parks and Recreation. The in-kind grant value is not to exceed \$3,000,000 and requires no cash match. This in-kind grant would fund the renovation and expansion of the Warner Park Headquarters.

This grant was approved by the Board of Parks and Recreation on February 6, 2024.
